Drexel R-IV Board of Education November 18<sup>th</sup>, 2019 Board Meeting – Media Summary

- 1. The board approved the consent agenda, which included the minutes of the October 21<sup>st</sup> regular meeting, the warrant report, payment of bills, treasurer's report and petty cash report. Under the consent agenda the board also approved candidate filing dates. The board candidate filing period for the April 7, 2020 General Election is from 8 AM on December 17, 2019 to 5 PM on January 21, 2020. The terms of members Jennifer Thomas, Ronnie Jacobs and Leah Martin are set to expire. The board appointed the following individuals to the School Health Advisory Council (Darrah Munter, Terry Mayfield, Janice Russell, Jon Stackhouse, Richelle Jackson and Kara Smith). The board also heard administrative reports (attached).
- 2. Under Old Business the Board:
  - a. Heard an update on construction projects. The lone outstanding item for the projects has been the punch-list for Washington Roofing to complete. They were on-site on November 4<sup>th</sup> to address those items. On November 18<sup>th</sup> the factory warranty representative was on-site and after conducting an inspection we should be receiving our factory warranty. Additionally, the district has received its' certificate of completion and warranties from the projects completed by McKinstry. Additionally, the board will hold a work session on November 21<sup>st</sup> @ 7:00 PM to begin looking at potential projects for Phase II to be completed during the summer of 2020.
  - b. Heard an update and had discussion regarding bus routes. Board approved reinstating the bus route that had been reduced previously.
- 3. Under New Business the Board:
  - a. Heard a presentation from Sara Jones with the Cass County Community Health Foundation on the dental screenings that the foundation had provided for Drexel students. 266 students received a free screening earlier in the fall provided by the foundation.
  - b. Heard a presentation from members of the Class of 2020 seeking permission for a senior class trip to Branson, Missouri. After some discussion the matter was tabled to gather more information.
  - c. The board renewed the district's property and liability insurance with M.U.S.I.C for 2020. The renewal rate is \$53,552, compared to last years' renewal of \$54,172.
  - d. Board selected Jayklin Smith as the district's representative to compete for the Missouri School Boards Association Belcher Scholarship.
- 4. Board held an executive session, taking the following action:
  - a. Approved Elaine Hamilton to serve as a long-term substitute teacher.
